

POWER OF ATTORNEY

THIS POWER OF ATTORNEY made this 27 day of July 2022 by [REDACTED] organized and existing under and by virtue of the laws of France whose registered office is [REDACTED] holding passport No. [REDACTED] to be its true and lawful Representative in the Hashemite Kingdom of Jordan and for it and in its name and on its behalf to do or perform all or any of the following acts and things:

1. To represent and act for the Company before all Ministries, authorities, Government Departments, bodies, institutions, persons and companies in Jordan.
2. To register the Company as a [REDACTED] foreign company in Jordan [REDACTED] in conformity with the Companies Law No. 22 of 1997 or any amendments thereto or replacements thereof or any other relevant legislation.
3. To sign, make, execute, file, submit and do all applications, instruments, documents, forms, declarations, acts, deeds and things which the said Representative shall consider necessary or proper for, or in connection with, the registration of the said Company [REDACTED]
4. To operate and manage the affairs of the Company's office in Jordan and to conduct the business thereof.
5. To accept service and receive letters and notices on the Company's behalf.
6. Generally, to act as the Company's duly authorized Representative in Jordan for all intents and purposes of the Companies Law No. 22 of 1997 and any amendments thereto or replacements thereof or any other relevant legislation.
7. A. To open any bank account or accounts and close same, operate and draw on same and to execute, sign, deliver, endorse and negotiate all banking forms, documents, cheques, bills of exchange. To withdraw and deposit funds. To transfer any funds to the agent and/or third parties. To request ATM cards, receive same and to receive the related passwords and to sign all the necessary conditions, requirements and forms in this regard. To request cheque books and receive same and to withdraw cheques and/or issuing same, and to cash cheques and receive its value. To Request electronic banking services, and to sign all the necessary conditions and forms related thereto, and to receive the passwords in this regard. To request statement/ statements of accounts and acknowledge the validity of the balances. To Open any other accounts in any currency and to transfer between such accounts. To close the account/accounts. To operate and/or activate and/or affecting the dormant accounts, and to acknowledge the validity of the balances and to sign on the compliance form of the American tax law with all its conditions and requirements.
B. The said attorney/representative is authorized to carry out the authorities mentioned in article 7/A above on the current and previously opened accounts.
8. To appoint, engage, hire, employ, remove or dismiss all necessary employees, workmen, and to agree upon, fix, increase, decrease and pay their wages, salaries, compensation or enticements. Generally, to act sign, make, execute, file, submit and do all applications, instruments, documents, forms, declarations, acts, deeds, letters and things which the said Representative shall consider necessary or proper for, or in connection with, any administrative matter including but not limited to the experience letters of the employees, salary transfer letters to banks, any letter relating to the employees. The said representative shall have the right to authorize others in writing in this regard.
